



# Membership Contract

## BUTTERFLY MEMBERSHIP

Monthly credit card (Visa/Mastercard) autopay charge of \$69 per 28 days entitles members to 8 classes per 28 days.

## MIND BODY BRONZE UNLIMITED MEMBERSHIP

Monthly credit card (Visa/Mastercard) autopay charge of \$99 per month entitles members to unlimited MYD (mat/yoga/dance) classes per month.

## MIND BODY PLATINUM UNLIMITED MEMBERSHIP

Monthly credit card (Visa/Mastercard) autopay charge of \$159 per month entitles members to unlimited MYD (mat/yoga/dance) + EQUIP (equipment) classes per month.

## UNLIMITED MYD CLASSES 3 OR 4 MONTH PAID IN FULL

One Time Payment cash or credit card (Visa/Mastercard) of \$297 or \$396 entitles members to unlimited MYD (mat/yoga/dance) classes for 3 or 4 months.

## STUDENTS ONLY UNLIMITED MYD MONTH 3 OR 4 Month Contract

Monthly credit card (Visa/Mastercard) autopay charge of \$99 per month entitles members to unlimited MYD (mat/yoga/dance) classes per month for 3 or 4 months.

- By purchasing the membership you agree to all terms and conditions in the current membership contract.
- Memberships may be purchased either online via our website or in the studio. Terms are the same regardless of purchase method.
- Memberships are credit card autopay for a term of 12 consecutive months unless otherwise stated
  - Butterfly 13 payments and Bronze & Platinum 12 payments
- There is a 6 month minimum commitment for all memberships and memberships will renew until cancelled via current contract terms.
- Memberships can be "upgraded" at any time however membership "downgrades" can only be made after the 6 month minimum is met.
  - Upgrade = Butterfly to Bronze or Platinum, Bronze to Platinum.
  - Downgrade = Platinum to Bronze or Butterfly or Bronze to Butterfly
- Please keep credit card information up to date including new card numbers if reissued or updated expiration dates.
- After the 6 month minimum commitment has been reached, 30 days written notice is required to cancel any membership and this written notice must be signed, dated, and given to the studio (Pilates Plus of Schaumburg 654 S. Roselle Rd. Schaumburg, IL 60193).
- E-mails and Phone Calls are currently not acceptable ways to cancel a membership (because of unreliability of phone/internet).
- If you choose to cancel, your membership will be cancelled 30 days after written notice is given. Any auto-pays that are scheduled during those 30 days will be processed and you will be eligible to continue taking classes thru the end of that month. No pro-rating of months is available.
- You may register only for the number of classes for which you have paid. In a Membership, you may not register for any classes beyond the latest date covered by your most recent auto-payment.
- Current valid email address is required. All notifications and updates will be sent via the email address you provided when registering. Please add PilatesPlus@gmail.com to your address book and check to make sure our messages do not go into your spam folder.
- In extenuating circumstances (prolonged travel etc.) members may choose to suspend their membership for a monthly administrative fee of \$19 Butterfly/\$29 Bronze/\$39 Platinum (in lieu of the regular membership rate).
- Pre-registration into the classes you wish to attend is required to reserve your space in class.
- Pre-registered guests will have priority into full classes. If you are not pre-registered, you are not guaranteed a spot in class.
- Failure to cancel with greater than 3 hours notice prior to class start time will result in that class counting as a used/attended class and will count toward your weekly/monthly class limit. If the failure to cancel prevented a wait listed member from utilizing that spot, a \$17 (MYD)/\$30 (EQUIP) fee will be assessed for each infraction.
- If clients do not cancel within the required amount of time, Pilates Plus of Schaumburg reserves the right to terminate or alter the terms of the membership, including transferring the member to the wait list to allow a member in good standing to enter class.
- Memberships cannot be shared.
- Pilates Plus reserves the right to terminate or modify classes, format, policies, procedures, or the membership contract at any time. Updated policies are always available on our website [www.PilatesMindBody.com](http://www.PilatesMindBody.com).
